By the Acting Governor of Porto Rico A proclamation

Sanitary Rules and Regulations No. 41.—Slaughter-houses; construction and management of; amendment to Sanitary Rules and Regulations No. 26, governing; promulgated.

The following amendment to Sanitary Rules and Regulations No. 26, as promulgated in Administrative Bulletin No. 81 having been approved by the Executive Council on September 21, 1915, is hereby promulgated for the information and guidance of all concerned:

REGULATION TO AMEND SANITARY REGULATION No. 26, GOVERNING THE CON-STRUCTION, MANAGEMENT OF SLAUGHTER-HOUSES, AND THE SUPPLY OF FRESH MEAT IN THE ISLAND OF PORTO RICO.

Section 1.—That between sections 20 and 21 of the Sanitary Regulation No. 26, "Governing the construction, management of slaughter-houses, and the supply of fresh meat in the Island of Porto Rico," promulgated the 8th of September, 1914, shall be inserted the following:

"Section 21.—The installation of portable stalls for the sale of meat on the streets is absolutely prohibited."

Section 2.—That sections 21 and 22 of the aforesaid regulation shall be in the future sections 22 and 23, respectively.

Section 3.—All regulations or ordinances in conflict herewith are hereby repealed.

Section 4.—This regulation shall take effect as soon as approved by the Executive Council and promulgated and published in accordance with section 23 of "An Act to reorganize the Service of Sanitation," approved March 14, 1912.

Being so promulgated and having been published in two newspapers of general circulation in the Island, in accordance with the

provisions of section 13 of Act No. 81, approved March 14, 1912, the said regulation, entitled "Regulation to amend Sanitary Regulation No. 26, governing the construction, management of slaughterhouses, and the supply of fresh meat in the Island of Porto Rico," on and after this date has the force and effect of law.

IN TESTIMONY WHEREOF, I have hereunto set my hand and caused the seal of the Government of Porto Rico to be affixed at the city of San Juan, this eighteenth day of October, A. D. nineteen hundred and fifteen.
